SUMMARY

The South Australian Government Premier and Cabinet Ministers will be attending the Adelaide Hills area on Wednesday 23 and Thursday 24 August 2023 as part of the Country Cabinet program.

Country Cabinet visits are an opportunity for members of the community, the Premier and government to discuss the challenges and opportunities unique to our region. As such the Mayor and Chief Executive Officer have been invited to present to Cabinet during the Cabinet meeting. Possible content for this presentation was discussed with Elected Members at Workshop on Monday 31 July 2023.

The purpose of this report is for Elected Members to endorse the final key areas of focus (subject to any minor amendments) for presentation to the Premier's Country Cabinet on Thursday 23 August.

 - e. Fund a Masterplan to manage the sport, recreation, community and civic infrastructure in Woodside

1. BACKGROUND

Council has been advised that the Premier and Cabinet Ministers will be visiting the Adelaide Hills for their next Country Cabinet on Wednesday 23 and Thursday 24 August. The Premier and Ministers will spend time within the region visiting local residents, business and organisations to discuss the challenges and opportunities unique to the region.

On Wednesday 23 August from 5pm the Premier will host a community BBQ and forum at the Mount Barker High School where members of the public will be welcome to attend. Active promotion of this opportunity will commence the week beginning 7 August 2023.

The Mayor and Chief Executive Officer of both Adelaide Hills Council and Mount Barker District Council have been invited to jointly present to the Strategic Cabinet Meeting on Thursday 24 August at the Onkaparinga Valley Football Club. This will comprise of 20 minutes for the joint presentation, followed by Q&A to give the Premier and Cabinet Ministers the opportunity to further understand what has been presented.

A copy of a PowerPoint presentation is required ahead of the meeting date and to provide some pre-reading for the Premier by 17 August.

For each key theme area a range of challenges and opportunities for the State Government to intervene and/or support through projects and initiatives have been suggested. From these key themes it is proposed that four key requests in particular be highlighted:

- 1. Upgrade and renewal of critical roads and stormwater infrastructure
- 2. Progress next stages of the Amy Gillett Pathway from Mt Torrens to Mt Pleasant
- 3. Redesign local transport services and provide more frequent services for better connectivity for our community and visitors
- 4. Recognise the uniqueness and significance of the Adelaide Hills through the development of a whole-of-government Regional Strategy Plan.
- 5. Fund a Masterplan to manage the sport, recreation, community and civic infrastructure in Woodside
