Accordingly, on this basis the principle that meetings of the Council should be conducted in a place open to the public has been outweighed by the need to keep the information and discussion confidential.

2. Appointment of Adelaide Hills Regional Waste Management Authority (AHRWMA) Chair – Confidential Item

SUMMARY

Consistent with the AHRWMA Charter, Constituent Council CEOs have recently participated in a Selection Panel, with the support of an external recruitment agency, for the recruitment process of an independent chair of the AHRWMA board.

The preferred candidate is required to be jointly appointed by an Absolute Majority of the Constituent Councils. The purpose of this report is to seek Council's consideration of the Selection Panel's recommendation.

RECOMMENDATION

Council resolves:

- 1. That the report be received and noted
- 2. That Council endorses Mr Adrian Skull being appointed as Independent Chair of the Adelaide Hills Regional Waste Management Authority for a 3 year term to commence upon the date of gazettal of the revised Charter.
- 3. That the AHRWMA be informed of Council's decision.

1. BACKGROUND

AHRWMA Charter

The AHRWMA is a Regional Subsidiary established by the Constituent Councils (Adelaide Hills Council, Alexandrina Council, Mount Barker District Council and the Rural City of Murray Bridge). It was established to facilitate, co-ordinate and undertake waste management including collection, treatment, disposal and recycling within the Adelaide Hills Region.

Governed by its Charter (with the revised Charter endorsed by all Constituent Councils in 2020) and the *Local Government Act 1999* (the Act) except as modified by the Charter in a manner permitted by the Act, it currently operates a landfill located at Brinkley (within the Rural City of Murray Bridge's land holdings) on behalf of its four Constituent Councils. It also operates two Resource Recovery Centres, one on behalf of the Adelaide Hills Council (at Heathfield) and the other on behalf of the Rural City of Murray Bridge.

AHRWMA Board Membership

In accordance with the revised Charter, the Board will comprise five (5) members (including Chair):

- One (1) person (who may be a Council Member, Employee or Independent Member) appointed by each Constituent Council. Each Council will also appoint a Deputy.
- One (1) person appointed jointly by Absolute Majority of the Constituent Councils, with relevant professional expertise, who is not a member or officer of a Constituent Council to be the chairperson of the Board
- The Chairperson of the Board shall be selected through a process determined by a panel comprising the Chief Executive Officers of the Constituent Councils.
- The Chair is appointed for a term of 3 years, and may be re-appointed thereafter.
- In accordance with the Charter, the Chair, will be an Independent Person

Adelaide Hills Council has already appointed its Board Member (John McArthur) and Deputy Board Member (Cr Ian Bailey) at its 22 March 2022 Council Meeting. The endorsement of the three (3) appointments by each of the remaining constituent councils are expected to be completed in the coming weeks.

AHRWMA Independent Chairperson

In accordance with the revised Charter, the Chair will be an Independent Person with relevant professional expertise. The Chair of the Board shall be selected through a process determined by a panel comprising the Chief Executive Officers of the Constituent Councils.

The four Constituent Councils' Chief Executive Officers undertook (or participated in/provided advice to) the following processes:

- Appointment of an independent recruitment consultant AM Consulting
- The Selection Panel was formed, which comprised:
 - Allison Ashby, Recruitment Consultant
 - Michael Sedgman, CEO Rural City of Murray Bridge
 - Andrew Aitken, CEO Adelaide Hills Council
 - Andrew Stuart, CEO Mount Barker District Council
- Five applications were received and following a shortlisting process, three applicants were interviewed
- Interviews were undertaken on 29 and 31 March 2022 and referee reports obtained for the preferred candidate
- The recommendation of the Selection Panel has been provided to all four Constituent Councils for endorsement

Preferred Candidate

The Selection Panel has recommended Mr Adrian Skull for appointment as the AHRWMA Independent Chair for a term of three (3) years.

Mr Skull is a former CEO of the City of Marion and Yankalilla District Council. He holds tertiary qualifications and possesses a detailed knowledge of the waste management industry. Further, Mr Skull holds current board memberships with the Green Adelaide Board, Green Industries SA Board, Australian Institute of Company Directors SA/NT Council and the Winston Churchill Memorial Trust SA.

Mr Skull advised that he was prepared to accept the sitting fee terms proposed.

3. OPTIONS

Council has the following options:

- I. Endorse Mr Adrian Skull being appointed for a three year term as Independent Chair of AHRWMA (Recommended).
- II. Do not endorse Mr Adrian Skull being appointed as Independent Chair of AHRWMA (Not Recommended). An Absolute Majority of Constituent Councils' support is required for the appointment and therefore Council's objection may not prevent the appointment depending on the support from other councils. If however, an Absolute Majority is not achieved, the AHRWMA will need to explore other recruitment options.
