2. BACKGROUND

Local Citizen of the Year Awards are conferred by local councils as part of the national awards scheme coordinated by the National Australia Day Council (NADC) and local branches.

The Awards recognise outstanding contributions to the local community by local Australians. For many years the Adelaide Hills Council has conferred the following awards on Australia Day:

- Citizen of the Year (1)
- Young Citizen of the Year (1)
- Community Event of the Year (1)
- Civic Awards (as many as determined by Council)

The Citizen and Young Citizen (under 30 years of age) of the Year Awards recognise outstanding individual achievements and contributions to the local community, while the Community Event of the Year Award recognises collaborative accomplishment.

The Civic Award category, which is not part of the NADC scheme, provides Council with the opportunity to recognise individuals or groups who may not be given one of the major awards, but who are considered to warrant recognition nonetheless. The Council has discretion as to how many Civic Awards are conferred and it has typically awarded multiple each year.

In accordance with resolution 270/17 that Council made on 14 November 2017, nominations are assessed by staff with recommendations made for the Council's consideration.

3. ANALYSIS

Nominations for the Awards were sought from the community through promotions in Council's communication channels of eNewsletters, social media, website, libraries and community centres, and direct emails encouraged community groups to promote the nomination period to their networks. Nominations for the 2022 Awards closed on Wednesday 24 November 2021.

The panel of staff members convened to evaluate the nominations and make recommendations contained in this report comprised the following:

David Waters – Director Community Capacity (Convenor) Karli Hull – Community Development Officer – Community Centres Stacey Dutton – Sport and Recreation Officer Josh Spier – Community and Social Planning Officer

The panel evaluated nominations for Citizen and Young Citizen of the year against the criteria recommended by ADCSA, which were:

- Contribution to the community
- Scope of impact on the Adelaide Hills
- Inspirational role model.

Likewise, the Community Event of the Year nominations were evaluated against the following criteria:

- The quality of the event
- The scope of impact the event has on the local government area
- The event's contribution to the community.

A summary of the recommendations is provided in *Appendix 1*. Those nominees not recommended for awards have been removed to protect the dignity and privacy of those individuals (who it is assumed are not aware of their nominations).

Citizen of the Year

Jess and Graham Jones of Bradbury were nominated for the extraordinary and selfless support they gave to their fellow community members impacted by the January 2021 Cherry Gardens Fire. Despite also being directly impacted by the fire, their property quickly became a staging point for community support (such as donations for animal feed) and the couple soon became a source of advice and assistance for their community.

In particular, Graham arranged and assisted with numerous property clean-ups, acted as a go-between with government agencies on behalf of impacted residents and helped with grant applications. Jess became a source of valuable help and information in respect to mental health, animal welfare, trees and waste removal and provided input into agency responses.

They have been widely recognised, albeit informally, by members of their community and are often referred to in discussions with agencies as key community supporters.

The panel considered Jess and Graham's efforts to be extraordinary and inspirational and therefore felt them to be most worthy of the nominees for this year's Citizen of the Year.

The ADCSA guidelines for Citizen of the Year Awards state:

Groups of people, organisations or couples will not normally be eligible for Citizen of the Year and Young Citizen of the Year, though in exceptional cases the selection panels reserve the right to consider such nominations.

The panel felt that this was an exceptional case warranting the award to both Graham and Jess as it was apparent that it was a genuine combined effort and that neither could have achieved what they did without the support of the other.

Young Citizen of the Year

Chantelle Wuttke, 18, of Aldgate, was nominated primarily for work she has done in her school environment (Hills Christian Community School), however it was apparent to the panel that the impact has had a far broader reach.

Chantelle has "single-handedly improved a school culture" largely through initiating and organising a number of wellbeing week activities and a school wellbeing expo with guest speakers and inclusive activities. The panel has heard that people in the broader community have been referring to her work at the school as an example and are applying it to initiatives within their own groups and networks.

Chantelle has also been extensively involved in volunteer work outside of the school, including as a leader on children's camps and fundraising for charity.

The panel felt that Chantelle is an inspirational role model for other young people and would be an excellent Young Citizen of the Year.

Community Event of the Year

The Lobethal Gardening Festival was a community initiated event born out of recovery activities following the Cudlee Creek Bushfire. Under the umbrella of the Lobethal Community Association, the event brought together residents, local businesses, schools and even aged care homes to showcase 11 local gardens, each with something different to offer visitors, with a focus on the wellbeing benefits of gardening.

Several hundred people attended this inaugural festival, which incorporated a formal Welcome to Country ceremony, garden club stalls, a Landscapes SA staff, Council stall, CFS education unit stall, a STEAM challenge for children and prominent guest speakers.

The panel considered this event to be an exemplar of communities leading and supporting their own recovery by activating their existing strengths to embrace new opportunities. The Lobethal Community Association is hoping to make this an annual event given this year's success.

Civic Awards

Ten people are recommended to receive Civic Awards. These include a number of people who were nominated for Citizen of the Year. Civic Award recipients have been selected for a variety of reasons including outstanding contributions to achieving outcomes for their communities over a period of time, going above and beyond the expectations of normal community volunteering and the example they provide for others.

In conferring the Awards, the Council should consider the following factors:

- Individual recipients (for Citizen and Young Citizen) must be Australian Citizens and their contributions should affect the Adelaide Hills Council district (they do not have to reside in the district),
- The Young Citizen of the Year must be under 30 years of age on Australia Day,
- Outstanding contribution to the community and inspirational achievements must be evident.

The panel considers each of the recommended recipients to meet these factors where applicable.

Awards will be presented by the Mayor or another Council Member at an Australia Day event of the recipients' choice (Stirling, Mylor, Uraidla, Woodside, or Gumeracha). Should a recipient prefer to receive their award on another day, arrangements will be made accordingly.

Recipients of the three major awards will be forwarded to the Australia Day Council of South Australia for consideration in the State Awards, presented by the Governor of South Australia.

4. OPTIONS

Council must determine which individuals and/or groups, if any, should receive Citizen of the Year Awards. The Council is not obliged to confer each award; to preserve the integrity of the awards it should only do so where genuine merit has been established.

The staff panel assigned to assess the Citizen of the Year Awards nominations was formed to allow time to properly consider each nomination and establish worthy award recipients. Its recommendations should therefore be strongly considered.

Nominee name	Reason for nomination, as stated by nominator(s)	Panel recommendation
Graeme and Jess Jones	Graeme and Jess Jones have been heavily involved in the clean up following the Bradbury fire in January 2021.	Citizen of the Year
	Their help to the local community has been extraordinary and eleven months after the fire that help continues.	
	This fire was not declared under the State Emergency Act and the community needed to step in to help. Graeme and Jess have put in an enormous amount of time and effort to help their neighbours in the surrounding area. Both Graeme and Jess's contributions have been widely recognised and appreciated by the local community. To my knowledge this has not been formally recognised.	
	This is a husband and wife nomination. This has been an extraordinary team effort.	
	While Graeme has been involved in numerous physical tasks involved in the aftermath of the fire, Jess has played a pivotal role in communicating with neighbours and supporting both them and her family through this ordeal. Graeme's health has been impacted by the prolonged effort.	
	For Graeme one aspect has been to arrange the delivery and the filling of large skip bins with metal roofing, fencing and other metal destroyed by the fire. This is arduous work and Graeme has worked to fill them on eight separate occasions. He has used his own machinery at considerable cost, helped with grant applications, acted as a go between with the Hills Fleurieu Landscape Board and oversighted the safe removal of asbestos from these damaged buildings.	
	Jess Jones has been a source of valuable help and information on what to do after a fire with respect to mental health (especially the impact on children), animal welfare, trees and rubbish removal, weed control, truck traffic on the road during clean-up operations and the coordination of agency responses.	
Chantelle Wuttke (18yrs)	Chantelle has been extensively involved with volunteer work, having been a leader on a number of children's camps over the years. She is an active member of her faith community and earlier in the year she organised a very successful fundraiser at Margaery's Orchard to raise funds for a children's charity that she is involved with.	Young Citizen of the Year
	Chantelle demonstrated impressive skills in her organisation of the Hills Christian Community School Wellbeing Week. She initiated a number of activities across the school such as a Wellbeing Expo, guest speakers from Headspace, a whole-school 'RU OK' day including staff members sharing their story to students and our first ever ELC-12 'Colour Run'.	
	All of these activities were to bring the school community together, which was a real need given that we have only become one campus at the start of 2021. The written communication, as well as face to face/verbal where possible, to staff members on both campuses, school Management, community contacts including external suppliers, as well as to students of all ages was clear, professional and timely.	
	During the whole-school Colour Run event, she was interviewed by a newspaper journalist, and clearly and appropriately communicated about the excitement the event was generating in helping forge cross-campus connections. As part of the promotion of her community events, she developed a series of professional and eye-catching posters which clearly communicated the important information, as well as a fun video in which our Principal was covered in coloured powder!	
	Chantelle, on a number of occasions this year, demonstrated excellence in public speaking through a number of speeches in front of her school over the year, including a Primary assembly where she promoted her wellbeing events. All of the events Chantelle organised this year had a clear goal supported by an underlying passion, for improving student wellbeing through improving	
	connections between students across the two newly-neighbouring campuses. It is not often that I can say that a student has single-handedly improved a school culture, and built connections between two previously separate campuses, but Chantelle has been able to achieve more as a single student / school captain (along with support people she elicited and helped develop) than anyone had thought possible. During the school's first year of co-location, it took a student like Chantelle to help build these bridges. She is a mature and responsible young woman who demonstrates empathy and care for her peers of all ages. She	
	interacts naturally and effectively with the Primary students, as well as students across the secondary school and her educators. She organised a number of	

	lunchtime activities involving our senior students who ran games and mindful colouring activities with our primary students. She also mentored a student in year 4 who needed additional support in developing her emotional literacy.	
Lobethal Gardening Festival (Georgie Pope, Liz Mattock, Kristina Vonow, Lynton Vonow)	Lobethal Community Association organized and hosted its inaugural Lobethal Gardening Festival on 31 October 21. The sub-committee for the Lobethal Gardening Festival was Georgia Pope (Chair), Liz Mattock, Kristina Vonow, Lynton Vonow. It involved a Welcome to Country, a smoking ceremony, multiple gardening clubs' stalls, the Adelaide Hills Council stall, Landscapes SA stall, the CFS' Education unit, seven private home gardens and four public gardens open all at once for anyone to visit, a STEAM challenge for primary school students, and guest speakers Evette Sunset at the Pocket Forest, and Sophie Thomson at the town hall, as well as collaboration with Rotary and multiple small businesses. The event was established for the following reasons: - to promote well-being for gardeners (particularly since the Cudlee Creek bushfire) in our local area by providing them with an opportunity to share their knowledge and experiences with others who visit their garden - to provide an acknowledgement that gardens don't have to be big, or even be our own, to have an impact on our well-being and be worthy of sharing with others - to provide an opportunity for communication and connection around a shared love for gardening - to educate the local and wider community regarding the well-being for the Lobethal community. Georgia Pope was an incredibly energetic and accomplished driver of this event. The event focussed on: - positivity and recovery since bushfires and during Covid - supporting local businesses for meals and breaks - bringing a different group of people to the town. Many come for the 'Lights' but we wanted to create something outside of that to focus on wellbeing that would attract a different sudience. We had over 250 people attend. - was inclusive of local business, lobethal CFS, Lobethal schools (private and public), and the retirement village. Peg (Phyllis Irene) Chartres	Peg has been the mainstay of a Christmas Lights Display at 5 Christmas Lane (formally 5 Ridge Road) since moving to Lobethal after the Ash Wednesday Bushfires in 1983. Since the mid 1990's she has had to nearly all the planning and setting up on her own due to my work injury which resulted in several spinal operations including four spinal fusions. She is now my fulltime career. Her lights display is famous throughout Australia and overseas. 	Besides her effort in presenting the Christmas Lane Lights Display Peg served on the Lights of Lobethal Committee for several years, is a member of, and a volunteer for, the Friends of Lobethal Bushland Park, and supports other local organisations. Her Lights Display has raised over \$25,000 for many charities and organisations. Peg is a very reserved person and most of her efforts are not publicized, so her extraordinary contribution to the community has not received any other public	
	recognition.	
Chris Badenoch	Chris is one of many quiet Uraidla community citizens. Born and Primary Schooled in Uraidla, Chris has been an active sportsman, playing football and tennis for Uraidla. Chris has been an office bearer for 11+ years in the Uraidla Tennis club and is the current President. Chris is also a long standing Trustee of the Uraidla and Districts Soldiers Memorial Park committee and has been President for the past 8 years.	Civic Award
	Under Chris's Park Presidency, he has realigned and beautified the Park entrance and Soldiers Memorial area. He has instigated the annual Anzac Day ceremony, which has been embraced by the local Community. Chris is also a longstanding Member and Arts Convenor for the annual Uraidla & Summertown Show where his talent as an artist is also celebrated. Chris is also a Management Committee member of the Show and spends his free time, of which there is little, mowing and maintaining the Showgrounds. Tania McGregor	Hundreds of hours of voluntary work over several decades for the Adelaide Hills Communities involve:- Library Services, shelving and packing books and assisting staff projects; Voluntary teaching at Crafers Primary school including cooking and food service training; Creating and managing a Welcome Knitting Club and craft group for the development of skills and technique and a sense of service to others particularly in welcoming new students into the School Community; Extending this Project as a contribution to an Exhibition designed to explore and highlight the History of Teddy Bears created by the Mt Lofty Districts Historical Society Inc.in. 2018. Most recently the commemorative project initiated by the Coventry Library brought several groups together through knitting dozens of red poppies in remembrance of World War 1. These poppies have been used annually by the Mt Lofty Districts Historical Society in commemorative displays for Anzac and Remembrance Days. These poppies were woven into a ceremonial wreath at the Stirling subbranch of the Returned and Services' League Centenary and One celebrations in October 2021. Tania McGregor is without doubt and exemplary citizen and constructive and creative member of the Adelaide Hills Communities. As a small child she migrated to Australia with her parents who were 'White Russian' refugees escaping the rigours of the Communist regime. Tallies family left all of their family members and communities behind. For Tania the importance of community became a reality when she married into the McGregor family — among the earliest European settlers in the Crafers District. Like many women, Tania has been a quiet achiever for whom nurturing her family as a wife, mother and grand-mother has her major focus. When opportunities emerged she was able to contribute her skills to the students of the Crafers Primary School on a voluntary basis. 	 Tania's community work extended and still continues within the Coventry Library where she is a familiar friendly and responsive on the Library volunteer programOshelving and packing books and contributing to Library activities. Her expertise in craft work and particularly knitting is contributed to the groups of knitters who meet weekly under the 'Craftemoon' banner bringing a warm collegiality to the community life within the Coventry Library premises. At these meetings she oversees the development of skills, recreates patterns, encourages beginners, maintains a warm and friendly involvement complete with cakes and nibbles for afternoon tea. During the Covid 19 shutdowns Tania invited the members to her own home so that their activities and support could continue. "Crafternoon" has now returned to their special place within the Library. In 2014-2018 the group, under Tania's guidance responded to the Library's commissioning of a collection of hand-knitted red poppies which could be used for ceremonial purposes during the WW! Centenary commemorations. These poppies have been used for Anzac and Remembrance display ever since. They have recently been woven into a wreath which was presented by the Stirling sub-branch for their own Centenary celebration in October 2021.
