1. BACKGROUND

Local Citizen of the Year Awards are conferred by local councils as part of the national awards scheme coordinated by the National Australia Day Council (NADC) and local branches.

The Awards recognise outstanding contributions to the local community by local Australians. For many years the Adelaide Hills Council has conferred the following awards on Australia Day:

- Citizen of the Year (1)
- Young Citizen of the Year (1)
- Community Event of the Year (1)
- Civic Awards (as many as determined by Council)

The Citizen and Young Citizen (under 30 years of age) of the Year Awards recognise outstanding individual achievements and contributions to the local community, while the Community Event of the Year Award recognises collaborative accomplishment.

The Civic Award category, which is not part of the NADC scheme, provides Council with the opportunity to recognise individuals or groups who may not be given one of the major awards, but who are considered to warrant recognition nonetheless. The Council has discretion as to how many Civic Awards are conferred and it has typically awarded multiple each year.

In accordance with resolution 270/17 that Council made on 14 November 2017, nominations are assessed by staff with recommendations made for the Council's consideration.

Priority C3.2 Support volunteering both organisationally and in the community as an essential element in delivering community outcomes and building wellbeing.

The annual awards presented on Australia Day are an opportunity for Council to recognise and celebrate members of the Adelaide Hills community who are volunteering their time, skills, and expertise to benefit the wellbeing of the wider district.

Legal Implications

Section 74 – General conflicts of interest of the Act set out the provisions regarding General Conflicts of Interest. In considering a General Conflict of Interest (COI), an impartial, fairminded person might consider that the Council Member's private interests might result in the Member acting in a manner that is contrary to their public duty. If a Council Member believes that they may have a General COI, they should consider declaring the interest and acting in accordance with s75B – Dealing with general conflicts of interest. Section 75 – Material conflicts of interest of the Act set out the provisions regarding Material Conflicts of Interest. In considering a Material Conflict of Interest (COI), a member of a council has a material conflict of interest in a matter to be discussed at a meeting of the council if a class of persons as defined in s75(1)(a-I) in the Act would gain a benefit, or suffer a loss, (whether directly or indirectly and whether of a personal or pecuniary nature) depending on the outcome of the consideration of the matter at the meeting. If a Council Member believes that they may have a Material COI, they should consider declaring the interest and acting in accordance with s75C – Dealing with material conflicts of interest.

Risk Management Implications

The recognition of community achievement and sacrifice through the Citizen of the Year Awards program will assist in mitigating the risk of:

Failure to provide for the wellbeing and interests of the community (through an outlet for formal recognition of community leaders) leading to negative attitudes towards Council in the community, disengaged community members and possible reduction in volunteerism.

Additional Analysis

Nominations for the Awards were sought from the community through promotions in Council's communication channels of eNewsletters, social media, website, libraries and community centres, and direct emails encouraged community groups to promote the nomination period to their networks. Nominations for the 2022 Awards closed on Friday 18 November 2022

The panel of staff members convened to evaluate the nominations and make recommendations contained in this report comprised the following:

Jennifer Blake – Manager Communications, Engagement, and Events (Convenor) Mark de Lange – Community Development Officer Youth and Recreation Meridee Jensen – Sport & Recreation Planner - Trails, Open Space Penelope Starling – Communications Officer - Communications, Engagement, and Events

The panel evaluated nominations for Citizen and Young Citizen of the year against the criteria recommended by ADCSA, which were:

- Contribution to the community
- Scope of impact on the Adelaide Hills
- Inspirational role model.

Likewise, the Community Event of the Year nominations were evaluated against the following criteria:

- The quality of the event
- The scope of impact the event has on the local government area
- The event's contribution to the community.

A summary of the recommendations is provided in **Appendix 1**. Those nominees not recommended for awards have been removed to protect the dignity and privacy of those individuals (who it is assumed are not aware of their nominations).

Citizen of the Year

Natasha (Tash) Hortle of Woodside has been nominated for the Citizen of the Year award for her incredible support to the community through many initiatives, such as events, bushfire response and recovery support, sporting clubs, education, and fundraising.

Despite having to evacuate herself, Tash supported many families who were affected by the most recent bushfires. She checked (physically) on families, spent time in the hospital with victims, and provided crèche support so that there would be a familiar face caring for

children. She also assisted with bushfire recovery by cleaning up fences and fallen trees, and checking on livestock. Not only has she provided practical support, she has continued to provide invaluable emotional support, often knowing when a cuppa and a chat is needed.

She is very connected with the Woodside Pre-school, having been a parent, Governing Council member, and becoming a staff member. During the school holidays she cares for the kindy and its animals and plants.

One of Tash's special gifts is the work she does with children with additional needs. She's constantly building her own knowledge, training staff, and working closely and supportively with parents. Tash began a voluntary music and movement class for children under five and their parents.

After losing her father to cancer two years ago she was motivated to make a difference to others who are impacted by cancer. She organised a successful 'Biggest Morning Tea', and also arranged a team to enter the Relay for Life in Balhannah. Her team, 'Giddy Up Girls', were one of 14 teams who took part in the event, raising \$23,000. The total raised at the event was \$73,585.

Tash is a well-known person and an outstanding asset to Woodside and the Adelaide Hills community. The panel consider Tash's efforts to be an outstanding example of someone making a difference, highly inspirational, and worthy of being awarded the Citizen of the Year award.

Young Citizen of the Year

Jasmin Scott of Woodside, (27) is an active contributor to the Lobethal Community, volunteering in a number of key organisations within the village.

She played a key role in coordinating information and social media as part of the Lobethal Bushfire Recovery Centre in the aftermath of the 2019 Bushfires.

She contributes to the Lights of Lobethal Committee and has invested significant time as the creator and organiser of the Valley of Praise Christmas Maze. The Maze is a free initiative that takes families on a tour of the Lights Festival, provides a gift bag, and a magical festive experience for 1000 children annually.

Jasmin's commitment to volunteering, her innovation and imaginative approach, and her compassion have inspired others to join her in a volunteer capacity.

The panel felt that Jasmin has dedicated herself to the service of others, is an inspirational role model for young people and would be an exceptional Young Citizen of the Year.

Community Event of the Year

The English Ale event in Mylor has been a long standing and unique event that attracts over 1000 people to the Adelaide Hills each year.

The event is produced on a voluntary basis, with the organisers working with many different groups, committees and organisations to produce the event. This includes tourism operators, local committees, businesses, the Adelaide Hill Council, and residents of the area.

As well as the Mylor Oval and Sherry Park, this event mobilises the memorial hall which hosts dancing, food, drinks and a concert which is always a sellout show.

The committee engages Adelaide Hills based suppliers where possible, from booking toilets and signage, to food vendors. They have also partnered with partnered with local small business accommodation providers to encourage visitors from other areas to extend their stay and experience more of the Adelaide Hills.

The community led venture has also worked with Adelaide Hills Tourism and secured a regional event grant from the South Australian Tourism Commission.

Aside from the event, that attracts many visitors, the committee also conduct their planning meetings and have a meal at the Aldgate Pump hotel to support the local business.

The panel believe this is a well organised event that brings both the local community together and many visitors to the region.

Civic Awards

Twelve people are recommended to receive Civic Awards. These include a number of people who were nominated for Citizen of the Year. Civic Award recipients have been selected for a variety of reasons including outstanding contributions to their communities over a period of time, going above and beyond the expectations of normal community volunteering and the example they provide for others.

In conferring the Awards, the Council should consider the following factors:

- Individual recipients (for Citizen and Young Citizen) must be Australian Citizens and their contributions should affect the Adelaide Hills Council district (they do not have to reside in the district),
- The Young Citizen of the Year must be under 30 years of age on Australia Day,
- Outstanding contribution to the community and inspirational achievements must be evident.

The panel considers each of the recommended recipients to meet these factors where applicable.

Awards will be presented by the Mayor or another Council Member at an Australia Day event of the recipients' choice (Stirling, Mylor, Uraidla, Woodside, or Gumeracha). Should a recipient prefer to receive their award on another day, arrangements will be made accordingly.

Recipients of the three major awards will be forwarded to the Australia Day Council of South Australia for consideration in the State Awards, presented by the Governor of South Australia.

3. OPTIONS

Council must determine which individuals and/or groups, if any, should receive Citizen of the Year Awards. The Council is not obliged to confer each award; to preserve the integrity of the awards it should only do so where genuine merit has been established.

The staff panel assigned to assess the Citizen of the Year Awards nominations was formed to allow time to properly consider each nomination and establish worthy award recipients. Its recommendations should therefore be strongly considered.

	After the bushfires, Tash checked (physically) on every family enrolled at school from the past year and coming year. She kept other staff members informed so they were able to support affected families. She also worked a crèche to support the affected families with a familiar face caring for their children. This in addition to all the support she provided to other member of the community after she herself had to evacuate and support family members	
	One family who lost everything and with a badly burnt husband had Tash at the hospital that night and there not just in the days after, but the months and years to follow. Tash with a band of volunteers helped clean up fences, fallen trees, checking on livestock etc. She was always checking with the recovery centre to keep everyone up to date. Although she may not have realised, she provided great emotional support and there were times when things were overwhelming, Tash always seem to know when a cuppa and a chat was needed. This was not the only family Tash was there for, she looked out for many in the community, providing support and still does today.	
	She began her relationship with Woodside Pre-school as a parent with two boys, then joined the Governing Council and became a staff member. She filled in many roles at the Pre-school including Early Childhood, lunch care, supervising pre-school support, administration officer, finance officer, coordinator, and mentor for new staff. During school holidays she takes care of the kindy, dropping in on most days to check on the animals and yards, liaise with builders, gardeners, etc and watering plants.	
	One of Tash's special gifts is the work she does with children with additional needs – always building her own knowledge, training staff, working closely and supportively with parents. Tash started up a voluntary music and movement class for children under five and their parents. She always planned great days for the children with lots of art and craft and outside adventure. Tash has a strong relationship with every pre-school or occasional care family, from their first contact with the site she	

	 makes sure she knows all the parents and children and engages with them throughout their time there, supporting them in any way she can. Tash lost her father, former Adelaide Hills Councillor Bill Gale, to cancer two years ago and this motivated her to do her best to make a difference to those in the future who are impacted by cancer. Tash organised a fundraiser for 'Biggest Morning Tea' for Woodside, she showed slides and photos of the community's involvement in the different social and sports events. It was a great success and wonderful to see people coming together to acknowledge the different events they were involved in. She organised a group of ladies called 'Giddy Up Girls' to enter the Relay for Life beginning on Saturday 2pm and finished at 9am on Sunday. The walk was around the Johnson Memorial Oval at Balhannah, 14 teams took part and raised \$73.585 of that \$23,000 was raised by Tash's team which was a great effort.
